JEKYLL ISLAND, Ga. – The Jekyll Island Foundation recently announced the election three newly appointed board members: Nancy Blackstone-Spiegel of North Port, Florida, and Hollis Linginfelter and Thomas "Tom" Lines of Atlanta, Georgia.

Nancy Blackstone-Spiegel - Private Practice R.N., Ph.D.

Mrs. Blackstone-Spiegel has been a member of the medical community for many years. In 1993, she earned a Ph.D. from California Coast University. She is currently in private practice, serves as a nurse/psychologist for the Boca Grande Health Care Clinic, and teaches as an adjunct professor at Everglades University.
